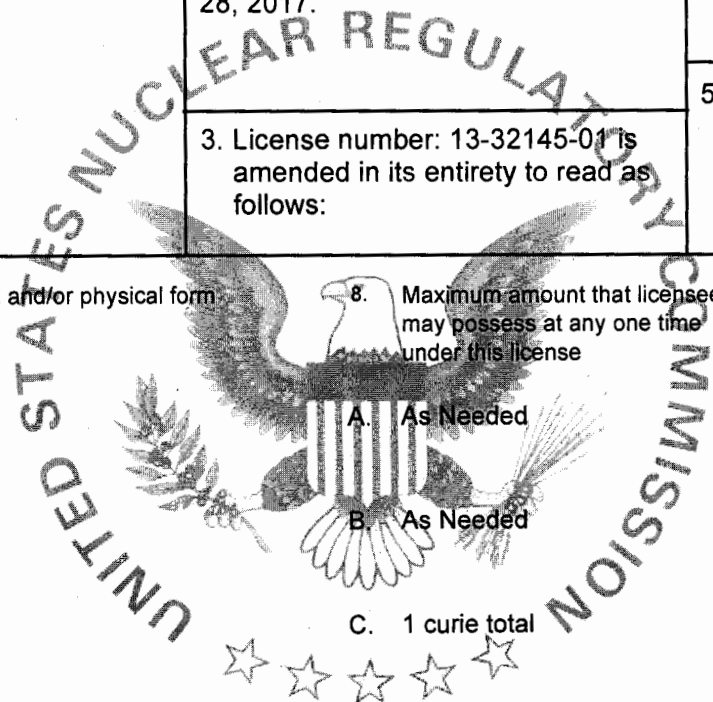


MATERIALS LICENSE

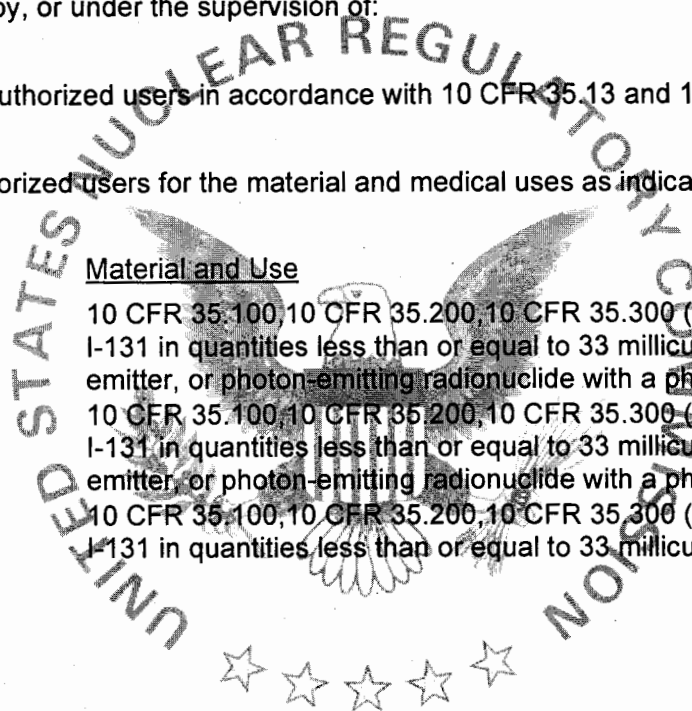

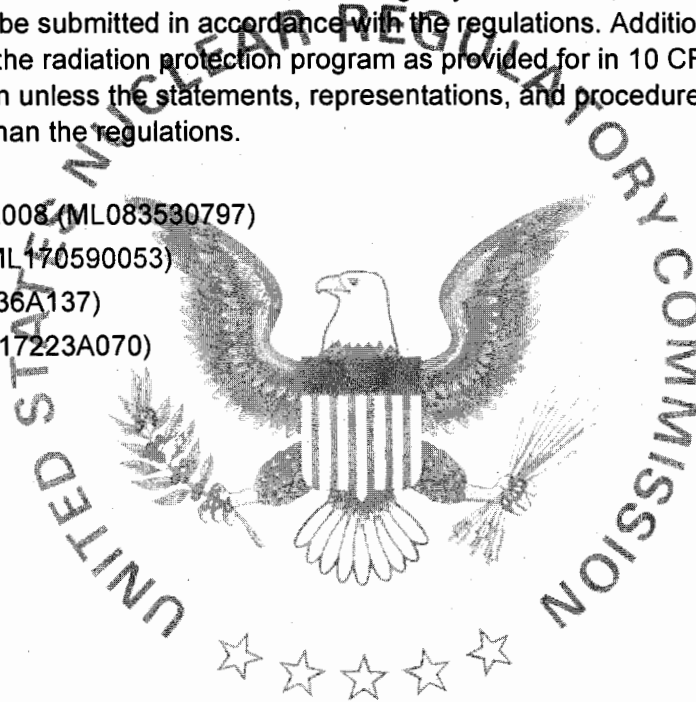
