At 3:18 p.m. while at 1.0E-04 percent power the reactor was automatically shutdown from a high startup rate trip caused by a faulty instrument circuit. The instrument was repaired and during startup preparations on July 10, Control Rod 8 would not move. The licensee has attributed the inability to move the rod to a drive motor brake malfunction and repairs are in process with reactor startup scheduled for July 10, 1980. This PN is issued for information only. The Resident Inspector is reviewing the licensee's actions in accordance with routine inspection program requirements. Neither the licensee or Region III plan to make a press release at this time. The State of Michigan is being notified. The licensee notified the NRC via Red Phone at 3:43 p.m. (CST) on July 9, 1980.
