The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2016-015) on May 19, 2016, to determine whether a former maintenance planning individual had been discriminated against for raising nuclear safety concerns at Oyster Creek. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the individual had been discriminated against.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
