Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, ASTrainingandtravel.Resource@nrc.gov, no later than Friday, March 9. Please request and do not exceed the Federal per diem of \$137 for your hotel. The meals and incidentals per diem for Houston, Texas is \$59. The first and last days of travel are calculated at 75 percent (i.e., \$48.25). Rental cars are not reimbursable. If you are authorized to drive your personal vehicle, mileage reimbursement is 54.5 cents per mile. A complimentary shuttle is available for transportation between the hotel and the training center for individuals staying at the hotels listed below. Please contact the front desk for details upon arrival. Those students who elect to stay at an alternate hotel will be responsible for their own transportation between the hotel and the training center.
