SUBJECT: OEDO-17-00396 – LETTER REQUESTING COMMENTS ON PROPOSED
10 CFR 2.206 DIRECTOR'S DECISION RE: DEPLETED URANIUM AT THE
POHAKULOA TRAINING AREA

Dear Dr. Reimer:

Your petition dated March 16, 2017,¹ addressed to the Executive Director for Operations, and subsequent information supplementing your petition, dated April 10, May 21, June 25, July 24, August 16, August 18, October 11, October 12, October 15, November 10, 2017 and January 15, 2018,² has been reviewed by the U.S. Nuclear Regulatory Commission (NRC) staff pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.206 of the NRC's regulations. This petition was filed with respect to Source Materials License No. SUC-1593,³ for the U.S. Army Installation Management Command's (Army's or Licensee's) Pohakuloa Training Area. My proposed decision on the petition is enclosed.

I request that you provide comments to me on any portions of the decision that you believe involve errors or any issues in the petition that you believe have not been fully addressed. The staff is making a similar request of the Licensee. The staff will then review any comments provided by you and the Licensee and consider them in the final version of the Director's Decision. This letter serves as your last opportunity to provide comments. Please provide your comments within 30 calendar days of the date of this letter.
