SUBJECT: MEETING SUMMARY

The NRC staff met with representative of Consumers Power Company (CPCo) at NRC Headquarters on January 27 and 28, 1993, for discussions of instrumentation and controls (I&C) Technical Specifications Amendment and proposed analog-to-digital conversions at the Palisades Plant. Enclosure 1 provides a list of attendees.

On January 27, 1993, the licensee and NRC staff discussed the safety-related analog-to-digital upgrades projected to be performed during the upcoming 1993 refueling outage. It was determined that radiation monitor and process transmitters were equipment of low safety significance and that the replacements can be performed under the 10 CFR 50.59 rule if the licensee determines there is no unreviewed safety question induced by these modifications. With respect to the modification of auxiliary feedwater flow controllers, the staff indicated that an audit or an inspection will be performed pending the licensee's 50.59 evaluation due to the safety significance of the auxiliary feedwater system. In addition, the staff stated that a proper 50.59 evaluation of such a modification will lead to the conclusion that this modification constitutes an unreviewed safety question.

On January 28, 1993, the staff and the licensee discussed pertinent changes to Palisades Technical Specifications Sections 3.16, "Engineered Safety Features System Instrumentation Settings," 3.17, "Instrumentation Systems," and 4.17, "Instrumentation Systems Tests" which relate to a Palisades Technical Specifications Amendment request dated November 15, 1991.
