The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2016-004) on December 1, 2015, to determine whether CB&I had discriminated against an employee for raising safety concerns at Pilgrim. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that that the individual was discriminated against for raising safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
