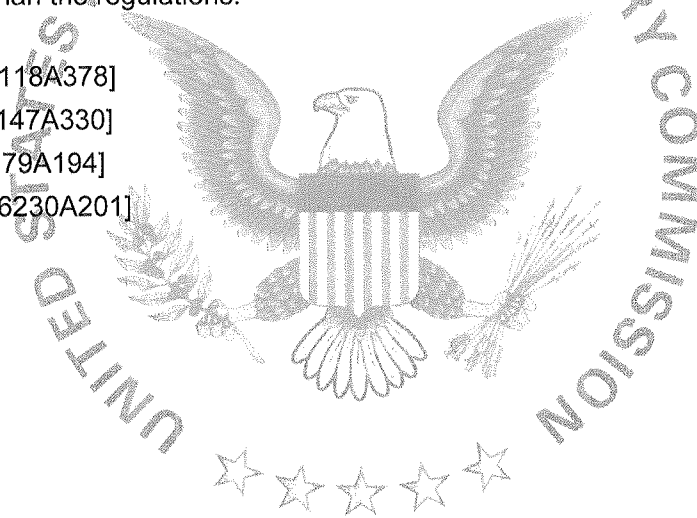
10. Licensed material may be used or stored at the licensee's facilities located at 9048 Sugar Estate, St. Thomas, U.S. Virgin Islands.
