Dear Mr. Eck:

On February 23, 2018, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Saint Lucie Nuclear Plant, Units 1 and 2, and discussed the results of this inspection with Dan Deboer and other members of his staff. The results of this inspection are documented in the enclosed report.

The report documents a violation for which the NRC is exercising enforcement discretion. The NRC concluded that an escalated enforcement violation occurred. In accordance with Section 3.10, "Reactor Violations With No Performance Deficiencies," of the NRC Enforcement Policy, the NRC is exercising enforcement discretion because the violation was not associated with a licensee performance deficiency.
