SUBJECT: SUMMARY OF FEBRUARY 14, 2018, MEETING WITH THE  
NUCLEAR ENERGY INSTITUTE AND INDUSTRY TO DISCUSS  
ANCHOR DARLING GATE VALVE PART 21 ISSUES

On February 14, 2018, the Nuclear Regulatory Commission (NRC) staff held a public meeting with representatives from the Nuclear Energy Institute (NEI) and industry to discuss progress on addressing Anchor Darling Gate Valve Part 21 issues.

NRC staff thanked industry for the progress being made to resolve Anchor Darling Double Disc Gate Valve issues and informed them that the NRC staff intends to make public a Temporary Instruction (TI) in the near future. During the meeting, NRC staff presented materials found at Agencywide Documents Access and Management System (ADAMS) as accession No. ML18044A983, and discussed "focus areas" that the staff has with the Boiling Water Reactor Owners Group (BWROG) guidance document.

During the discussion, the NRC discussed a collated database of all the industry information. The staff agreed to make it available to the public. This database is available at ADAMS Accession No. ML18053A904. A report generated by this database is available at ADAMS Accession No. ML18053A023.
