On January 30, 2018, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Comanche Peak Nuclear Power Plant, Independent Spent Fuel Storage Installation. The NRC inspector discussed the results of this inspection with Mr. J. Dreyfuss, Plant Manager, and other members of your staff. The inspector documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any finding or violation of more than minor significance.
