The U.S. Nuclear Regulatory Commission (NRC) received a license application from Holtec International (Holtec) to construct and operate a consolidated interim storage facility for spent nuclear fuel at the Holtec site in Lea County, New Mexico. The documents are associated with the NRC's environmental review of the Holtec HI-STORE license application.
