POWER DISTRICT'S DECOMMISSIONING FUNDING PLAN UPDATE FOR FORT
CALHOUN STATION INDEPENDENT SPENT FUEL STORAGE INSTALLATION

Dear Ms. Fisher:

By letter dated March 31, 2015, Omaha Public Power District (OPPD) submitted for U.S. Nuclear Regulatory Commission (NRC) staff review and approval, a decommissioning funding plan update (DFP Update) for the independent spent fuel storage installation (ISFSI) at Fort Calhoun Station (Agencywide Documents Access and Management System Accession No. ML15090A763). The NRC staff reviewed OPPD's DFP update for the ISFSI and believes OPPD's submittal was not sufficient to meet the intent of the requirement in 72.30(c). The DFP update does not provide sufficient information to allow the NRC to determine that the events listed in 10 CFR 72.30(c)(1)-(4) have been specifically considered.

The NRC staff need the information identified in the enclosure to this letter. We request that you provide this information within forty-five (45) working day of the date of this letter. Inform us at your earliest convenience, but no later than 2 weeks prior to the due date, if you are not able to provide the information by that date. To assist us in re-scheduling your review, you should include a new proposed submittal date and the reasons for the delay. Discussion of the request for additional information (RAI) and RAI response date occurred February 27, 2018.
