SUBJECT: Appointment of Radiation Safety Officer

1. References:

2. Effective immediately and until revoked, you are hereby appointed as the U.S. Army TACOM Radiation Safety Officer.

3. The duties of the Radiation Safety Officer include:


- a. Implement an effective radiation safety program for TACOM that addresses all Army radiation safety program requirements.
- b. Maintain situational awareness and oversight of the TACOM Radiation Safety Program and provide programmatic information and technical advice to the TACOM Chain of Command.
- c. Provide compliance policies and procedures, as well as oversight to all TACOM activities with a radiation mission, that are necessary for the efficient execution of the TACOM Radiation Safety Program.
- d. Provide advice and assistance to all TACOM activities concerning the administration of the overall command use of ionizing and non-ionizing radiation. This includes the ability to halt an operation at TACOM locations that may pose a risk of radiation exposure to personnel, and to provide recommendations to the TACOM

SUBJECT: Appointment of Radiation Safety Officer

Commander to cease operations of TACOM radioactive commodities that are deemed to pose a radiation exposure risk to personnel.

e. In the event of a radiation related incident or accident, provide expert guidance as a member of the investigation team to resolve the issue, recommend corrective actions to prevent further incidents, and track the implementation of the approved corrective actions. Provide timely reports to the Commander, Headquarters, U.S. Army Materiel Command, Department of the Army Radiation Safety Officer, and the Nuclear Regulatory Commission as required.
