SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY ON MARCH 8, 2018

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 1 public meeting with Southern Nuclear Operating Company (SNC) on March 8, 2018. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4.

Summary of Meeting:

On March 8, 2018, staff from the NRC conducted a public meeting with representatives from SNC to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4. Specifically, the meeting discussed (1) the UIN for ITAAC Index No. 602 and (2) clarification questions related to LAR 17-040.

The first topic discussed was the UIN for ITAAC Index No. 602. The staff noted that they wanted to clarify the remarks made in a public meeting on February 15, 2018, because the staff incorrectly identified that SNC would need to submit an LAR to correct the design commitment language of ITAAC Index No. 602. The staff clarified that they reviewed and found the UIN for ITAAC Index No. 602 acceptable because the UIN contains sufficient information to demonstrate that test and analyses will be performed, and the acceptance criteria will be met.

The staff further discussed that during the review of the UIN, the staff had an internal discussion on how the design commitment is worded. While the acceptance criteria wording focuses on protecting the Class 1E system from credible faults, consistent with General Design Criterion (GDC) 17, the design commitment requires the Class 1E system to provide electrical isolation between the two non-Class 1E systems, which is not required by GDC 17. However, given the configuration of the design, protecting the Class 1E system also serves to provide isolation between the two non-Class 1E systems. Adding the words "itself and" after the word "between" in the design commitment would align the design commitment with the acceptance criteria wording and the GDC 17 requirement. The staff discussed that if SNC also thinks the design commitment (and the corresponding Tier 1 design description) could be better worded, then SNC could submit a LAR to do so. SNC stated that they understood the staff's clarification.

Additionally, the staff noted that the first public version of the ITAAC Dashboard Report, which presents graphics showing the current status of ongoing ITAAC notification reviews as well as historical performance data for VEGP Units 3 and 4, is now available on the NRC's public website. The staff discussed that the ITAAC Dashboard Report is generated using the same information the staff uses to develop the ITAAC Notifications Review Status Report for each unit. The staff noted that they will aim to update the ITAAC Dashboard Report every 2 weeks and will also consider any feedback received for future updates.

The address for the report is www.nrc.gov/reactors/new-reactors/oversight/itaac. The staff will also post a link to the Dashboard Report next to the existing links to the ITAAC Notifications Review Status Reports on the web pages for VEGP Unit 3 and VEGP Unit 4.

The second topic discussed was clarification questions related to LAR 17-040. The staff and SNC discussed the clarification questions to gain a common understanding of why the LAR characterizes the proposed changes as consistency changes. SNC agreed that in Question 9, Note 13 was applied to the incorrect floor in Tier 1 Table 3.3-1. SNC stated that in a supplement to the LAR, they would correct the error and provide responses to the clarification questions.

At the end of each topic discussed, there was an opportunity for the public to provide comments and ask questions. There were no comments or questions from members of the public.
