SUBJECT: SUMMARY OF FEBRUARY 21 AND 22, 2018, TELEPHONE  
CONFERENCES TO DISCUSS HONEYWELL'S RESPONSES TO  
REQUESTS FOR ADDITIONAL INFORMATION REGARDING  
LICENSE RENEWAL APPLICATION RELATED TO  
ENVIRONMENTAL AND CHEMICAL PROCESS SAFETY REVIEWS,  
HONEYWELL METROPOLIS WORKS (COST ACTIVITY  
CODE/DOCKET/EPID 000224/04003392/L-2017-RNW-002)

On February 21 and 22, 2018, the U.S. Nuclear Regulatory Commission (NRC) staff held telephone conferences with representatives of Honeywell International Inc. (Honeywell or the licensee) to discuss follow-up questions on Honeywell's responses to NRC's request for additional information (RAI) in the areas of environmental and chemical process safety, concerning Honeywell's license renewal application (LRA) submittal dated February 8, 2017 (Agencywide Documents Access and Management System [ADAMS] Accession Number ML17048A263), as supplemented by letter dated September 20, 2017 (ADAMS ML17291A652) for its Metropolis Works (MTW) facility.

By letter dated October 25, 2017 (ADAMS ML17293A235), the NRC sent a RAI to Honeywell pertaining to the staff's environmental review. By letter dated January 22, 2018 (ADAMS ML18029A119), Honeywell provided its responses to the staff's RAI. During the February 21, 2018, follow-up call, the NRC staff discussed Honeywell's responses to the RAI questions, labeled as "GEO-2," pertaining to site geologic characteristics, and "WM-4," pertaining to waste management practices. As a result of the discussion, concerning GEO-2, Honeywell agreed to revise its Environmental Report to reflect the correct location of the formations and to provide a written response concerning a waste minimization program.

By letter dated November 7, 2017(ADAMS ML17298B769), the NRC sent a RAI to Honeywell pertaining to the staff's chemical process safety review. By letter dated February 2, 2018 (ADAMS ML18043A121), Honeywell provided its response to the RAI. During the February 22, 2018, follow-up call, the NRC staff discussed certain RAI questions and the associated responses from Honeywell. As a result of the discussions, Honeywell stated that it would update its planned revision to the LRA as specified in the response to RAI 6-2, by removing the discussion of Section 6.3 on the integrated safety analysis (ISA) summary. Honeywell also stated that it would revise the responses to RAI 6-13 and RAI 6-19, respectively, after it finalizes the responses to the NRC's RAI on ISA summary by letter dated February 12, 2018 (ADAMS ML18031A726).

The telephone conferences supported the NRC staff's efforts to clarify the information obtained from Honeywell.

The enclosure contains a list of those who participated in the telephone conferences on February 21 and 22, 2018, respectively. Honeywell MTW has had an opportunity to review and comment on this summary.
