This refers to your license amendment request dated January 16, 2018. Please find enclosed Amendment No. 22 authorizing the new location of use at 1060 South Governors Avenue, Suite 101, Dover, Delaware, the removal of the facility located at 144 South Governors Avenue, Dover, Delaware, and change in organizational chart.

The facility at 144 South Governors Avenue, Dover Delaware may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).
