In addition to that request, please change the name on our NRC license to: Beaumont Hospital Trenton


There is no change of ownership; this is a change in name only.

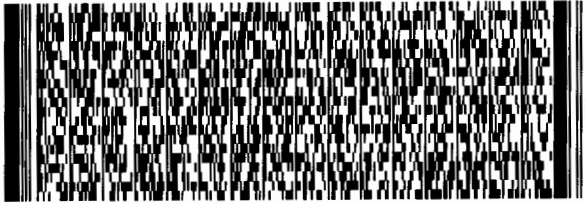

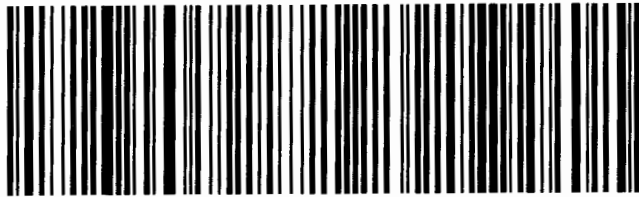
