I spoke with your Radiation Safety Officer on March 8, 2018, and indicated that the following remaining proposed authorized users will require additional documentation to support their authorization: William Almasy, M.D., Daniel DiGiovine, M.D., Joseph Dorchak, M.D., Mark Hackney, M.D., Thomas Koay, M.D., Richard Person, M.D., and Jason Stewart, M.D.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
