Dear Mr. Schierman:

By letter dated December 3, 2011, Uranium One USA submitted to the U.S. Nuclear Regulatory Commission (NRC) a request to amend its Willow Creek Project Source Materials License SUA-1341 to authorize construction and operation of the Ludeman Project In Situ Recovery (ISR) expansion in Converse County, Wyoming. In April 2013, during the NRC staff's review of this application, Uranium One USA notified NRC staff that it planned to change the design of the proposed Ludeman Project. The licensee submitted a revised technical report on June 28, 2017 (ML17192A357) as well as a revised environmental report on August 25, 2017 (ML17261A460) incorporating the major revisions to the original technical report based on the April 2013 "change of design" request, and responses to RAIs and open issues.

The NRC staff has completed its review of the Ludeman Project license amendment request and approves this request. Enclosed, please find the NRC staff's "Safety Evaluation Report, License Amendment for the Ludeman Project to the Willow Creek In Situ Recovery Project Converse County, Wyoming, Revision 1," (Enclosure 1) and Source Material License No. SUA-1341, Amendment 6 (Enclosure 2). Amendment 6 of Source Material License SUA-1341 reflects changes to the license conditions to include the Ludeman Project in licensed activities at the Willow Creek Project as evaluated and described in Revision 1 of the SER. Revision 1 of the SER amends Section 5.7.6, "Contamination Control Program," to include an evaluation of the licensee's qualification and training program for individuals who perform surveys under the contamination control program by removing the last two sentences in license condition 9.8. Revision 1 also adds references throughout the SER to the January 11, 2018 letter from the licensee and includes an editorial change to correct the number of license condition 10.22 to license condition 10.29 throughout the document. Uranium One USA accepted the license conditions in this Amendment in a public meeting held February 22, 2018 (ADAMS Accession No. ML18078A748) and by email dated March 15, 2018 (ADAMS Accession No. ML18075A170).

Pursuant to requirements under the National Environmental Policy Act, staff prepared an

Environmental Assessment for this action (ML18183A225). The revision to license condition 9.9 described in the final EA was accepted by the licensee by email dated August 2, 2018 (ADAMS Accession No. ML18227A065). The Finding of No Significant Impact for this action (ADAMS Accession No. ML18131A235) was published in the *Federal Register* on August 14, 2018 (83 FR 40357).
