
Ms. Nguyen,

This letter is to inform you that Jefferson Radiology, P.C. ("Jefferson") has contributed 51% of its ownership interest in its free-standing imaging centers to Connecticut Imaging Partners, LLC, ("CIP") a long-standing imaging center joint venture between Jefferson and Hartford Hospital. The authority of Jefferson Radiology's Materials License has not changed.


As part of its contribution of the imaging center assets to CIP, Jefferson Radiology is requesting a licensee name change to License No.: 06-28502-01. The proposed name change is; Connecticut Imaging Partners, LLC. As noted above, CIP is a joint venture that is and will continue to be owned by Hartford Hospital (Docket No.: 030-01239 / License No.: 06-00253-04) and Jefferson. Jefferson will continue to manage CIP's Glastonbury, CT location where the Nuclear Medicine services are located. There is no change in location, leadership, technical staff, Radiologists, procedures, equipment nor will the Radiation Safety Officer change. The contact for the Materials License will not change. The surveillance program is current and will continue to remain current.


Ms. Nguyen,

This letter will provide you with clarifying details regarding Jefferson Radiology, P.C.'s ("Jefferson") ownership and status. On September 27, 2017, the former physician owners of Jefferson sold 100% of their ownership interest in Jefferson to a single physician, Curt Pickert, MD, who now is Jefferson's sole shareholder.


Following the sale to Dr. Pickert, Jefferson's operations remain the same, to wit, its name, legal structure, clinical and technical staff, management team and operations, including all locations and scope of services, remain unchanged. Similarly, the authority of Jefferson Radiology's Materials License did not change and Jefferson's radiation-related equipment, processes, staff and Radiology Safety Officer remain the same and at the same physical location.
