PROPOSED IMPOSITION OF CIVIL PENALTIES - \$90,000

This is to inform the Commission that a Notice of Violation and a Notice of Proposed Imposition of Civil Penalties in the amount of Ninety Thousand Dollars (\$90,000) will be issued to the Public Service Electric and Gas Company on or about February 18, 1981. This action is based on eight violations relating to deficiencies found in the radiation protection program, which were culminated by (1) the entry of two individuals into the fuel transfer tube with inadequate provisions for radiation protection; and (2) the entry of three individuals into the reactor cavity while the in-core flux thimbles were withdrawn.

A news release will be issued about the time the licensee receives the notice. The State of New Jersey will be informed.

It should be noted that the licensee has not been specifically informed of the enforcement action. The schedule of issuance and notification is:

The licensee has 25 days from the date of the Notices in which to respond. Following NRC Staff evaluation of the response, the civil penalties may be remitted, mitigated or imposed by Order.
