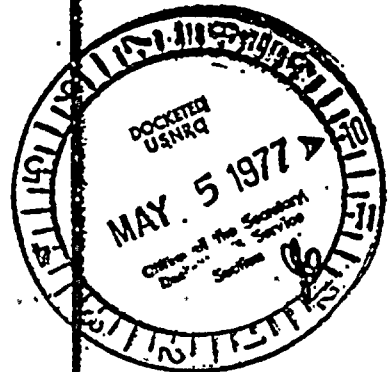

company's nuclear plant in St. Lucie County will be discharged into the Atlantic Ocean today, an FPL spokesman said Friday. The water has been diluted to the point that when it is released into a cooling canal on its way to the ocean, the spokesman said, a person could drink the canal water without any radiological effect. The water is to be funneled from the canal into a pipe for discharge into the ocean 1,500 feet offshore. The 3,000-gallons of reactor cooling water overflowed a storage tank April 6 when the unit was shut down briefly following a minor fire the previous week. The water went into a 3.5-million gallon pond at the FPL plant.
