This refers to the routine resident safety inspection by Mr. T. Kenny, of this office, on March 1, 1986 to March 31, 1986, at the Salem Nuclear Generating Station, Hancocks Bridge, New Jersey. The inspection consisted of document reviews, interviews, and observation of activities. The findings were discussed with Mr. J. M. Zupko, Jr. of your staff.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (47 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
