This refers to your request to transfer control of your license received February 12, 2018. In order to continue our review of your request, the following additional information is needed:

1. You stated in our telephone conversation on March 27, 2018, that the transferee has decide to change the company name from FE Polytech to APG Polytech. Please provide written documentation as to the new company name and any documents that can link the change in names.
2. In your initial request for transfer of control of your material license, you answered the nine items from Appendix E of NUREG-1556, Volume 15, Rev. 1, Consolidated Guidance About Materials Licenses, Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses without knowing who the transferee would be. Please provide, in writing from the transferee, the answer to the questions from Appendix E of NUREG-1556, Volume 15, Rev. 1, Consolidated Guidance About Materials Licenses, Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses.
