Dear Mr. Flaherty:

On May 27, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Calvert Cliffs Nuclear Power Plant, Units 1 and 2. On June 6, 2016, the NRC inspectors discussed the results of this inspection with Mr. Mark Flaherty, Plant Manager, and other members of your staff. The NRC is reissuing this report to document the change in significance on one non-cited violation to a minor violation. Changes to this report are reflected in the Summary Section, Section 3.2. b, and the Supplemental Section of the enclosed inspection report. The revised results of this inspection are documented in the enclosed inspection report. This report amends the previous report documented in the Agencywide Documents Access and Management System (ADAMS) Accession No. ML16159A268.

If you contest this violation or its significance, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region I; the Director, Office of Nuclear Security and Incident Response; the Director, Office of Enforcement; and the NRC resident inspector at the Calvert Cliffs Nuclear Power Plant, Units 1 and 2.

If you disagree with a cross-cutting aspect assignment in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the Regional Administrator, Region I; the Director, Office of Nuclear Security, and Incident Response; and the NRC resident inspector at the Calvert Cliffs Nuclear Power Plant, Units 1 and 2.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390, "Public Inspections, Exemptions, Request for Withholding," of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records (PARS) component of the NRC's ADAMS.
