Please find my responses to your questions below in blue.

- On intermediate foreign consignees – are you still using the third entity – Praxair – that is on /01?  
We would like to leave the Praxair entity on the license in the event that we need to revert back to supply through them. We are merging with Praxair later this year.
- On ultimate foreign consignees – I see you are adding two additional – are you still keeping the five from /01 and adding the two listed on page 3 of application?  
Yes. We are not removing any of the other parties.
- You are increasing the total deuterium gas from 1170 (amendment /01) to new requested figure of 1505 kgs of deuterium gas, correct?  
Yes. That is correct.
- Lastly, - I see you are extending expiration date to 12/31/2022.  
Yes. That is correct.
