This refers to the initial inspection of your fitness-for-duty program implemented at Artificial Island. The inspection was conducted March 12-15, 1990, by R. Albert and A. Della Ratta of this office; L. Bush of Headquarters; and G. Pirtle of Region III.

Areas examined during the inspection are described in the NRC Region I inspection report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of this inspection, three non-cited violations were observed. These violations were not cited because they were self-identified and corrective actions were being taken, or they were minor in nature. In addition, two unresolved items were identified.

We understand that you have changed the process for randomly testing those persons who have infrequent access. You are requested to respond, in writing, within 30 days of receipt of this letter with a description of the current process for randomly testing persons having infrequent access.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room.
