**BRIEF DESCRIPTION OF WORK ALTERNATE I**

(a) The title of this project is: Renewal of Oracle-Sun Maintenance Services

(b) Background: The NRC is dependent on Oracle-Sun's Solaris Operating System to run five servers in the NRC Data Center. The Oracle-Sun maintenance services will provide access to Solaris support from Oracle which is required to ensure continuous operations of the servers in the Data Center.

(c) Objective: The objective of this procurement is to purchase maintenance renewal services on a brand name only basis from an authorized NASA SEWP V Contractor that sells Solaris Operating System maintenance renewals for software that is manufactured by Oracle Corporation.

(d) Description: See details on page 1.

(e) Limited Sources Justification: This brand name procurement of Oracle Corporation maintenance renewals will allow the agency to continue the use of previously purchased Oracle-Sun Solaris products which currently support the NRC Data Center for web and application hosting. These Oracle products and maintenance services have been tested, secured and are in production and serve as an integral part of the NRC's current enterprise.

Even if other COTS products could currently meet the NRC's requirements, the NRC does not currently intend to replace its investment in Oracle. To do so would cause the NRC to incur significant additional cost, would be highly disruptive and would introduce significant risk to the NRC.

**PERIOD OF PERFORMANCE**

This contract shall commence on 1/31/2018 and will expire on 1/30/2019.

**CONSIDERATION AND OBLIGATION-FIRM-FIXED-PRICE**

The total amount of the Firm-Fixed-Price portion of this contract is \$11,166.75, and this amount is fully-funded.
