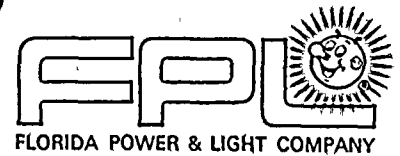

ATWT Analysis

Florida Power & Light Company hereby requests that its letter of September 27, 1974 requesting an extension of time until December 1, 1974 for filing of the "ATWT Analysis" for St. Lucie Units 1 & 2 be withdrawn and superseded by this letter.

An additional extension of time for submittal from December 1, 1974 until June 1, 1975 is hereby requested. This delay in submittal is necessary because data for the "ATWT Analysis" has not been received from Combustion Engineering Company, the reactor manufacturer.

FPL has been informed by Combustion Engineering Company, that the complete analysis will be delayed for about six months.

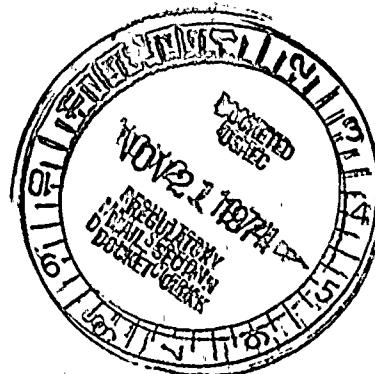
FPL will then require time to review and evaluate the analysis. It is expected that about four weeks will be required for a thorough FPL review.
