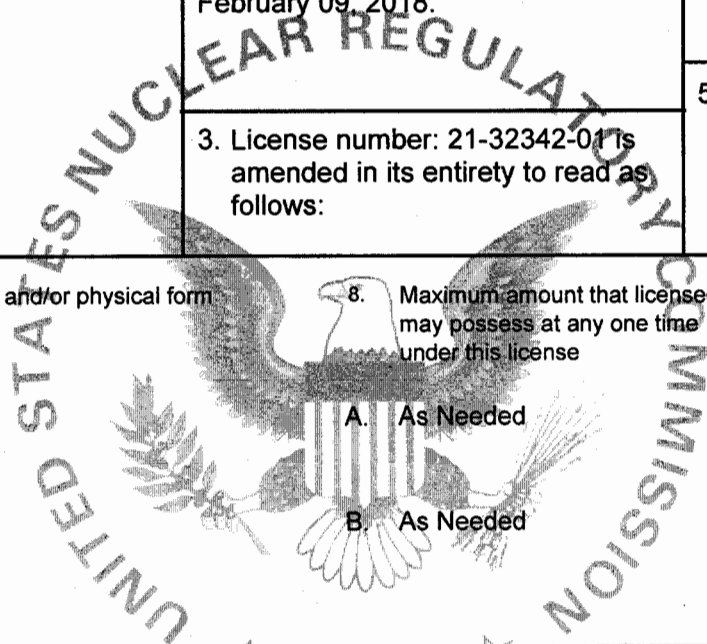


MATERIALS LICENSE
