Part 95. I am also aware of the protective measures implemented by Maine Yankee with respect to FOCD and FOCI requirements. I certify my understanding of the protective measures implemented by Maine Yankee with respect to exclusion of foreign-controlled sponsors and their representatives from access to classified information and special nuclear material.
