Dear Dr. Barr:

This refers to your license amendment request dated March 5, 2018. Please find enclosed Amendment No. 21 removing authorization for carbon-14, fluorine-18, phosphorus-32, copper-64, and gallium-68. It also removes two authorized users and releases laboratory D568-2 and A426 from the licensing basis.

The laboratories D568-2 and A426 may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
