Dear Mr. Reed:

Enclosed is Amendment No. 29 to your NRC Material License No. 21-08362-12 in accordance with your request.

Items 6-9 on your license have been updated in accordance with your request and the applicable Sealed Sources and Devices Registries; note that device manufacturer names have been updated to the current company names registered with the NRC or Agreement States. License Condition 13. E. has been updated as it was inadvertently changed with the last amendment to authorize you to perform leak test analysis; the license will now permit you to continue collecting leak test samples, but not to perform the test analysis. Please note that Condition 24 and Condition 25 regarding portable nuclear gauge security barriers, and cleaning, maintenance, and repair of portable gauges have been added to your license. These conditions were inadvertently not included on previous amendments.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
