SUBJECT: MEETING SUMMARY REGARDING CALCIUM FLUORIDE POND
CLOSURE STATUS UPDATE, HONEYWELL METROPOLIS
WORKS APRIL 12, 2018

On April 12, 2018, the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of Honeywell International (Honeywell) held a Category 1 meeting to discuss the current calcium fluoride pond closure status at Honeywell's Metropolis Works facility.

A portion of the meeting was open to the public for observation, during which Honeywell provided an overview of its pond closure plan and related supporting activities in general. The remaining portion of the meeting was closed to the public because specific details included security-related information and proprietary information related to the proposed pond closure plan.

The meeting provided an effective and efficient forum of communication, and benefited both the NRC staff and Honeywell representatives. The meeting was useful to the NRC staff in understanding Honeywell's proposed plan and associated activities in more detail, and it allowed an opportunity to discuss regulatory and licensing aspects of the updated pond closure related activities. Honeywell indicated that it plans to submit a license amendment request reflecting the revised pond closure plan to the NRC for review. No NRC staff decision was made during the meeting.
