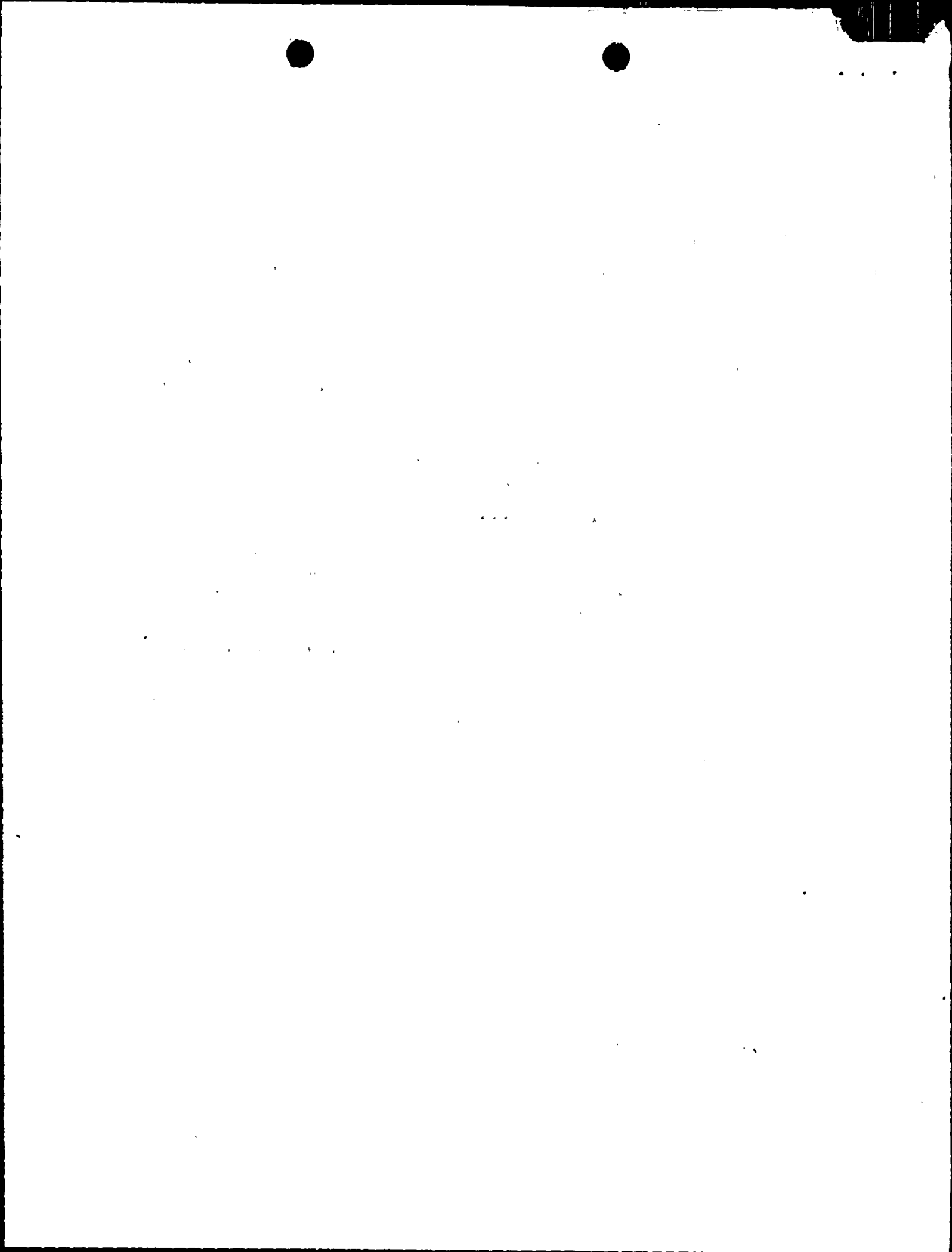

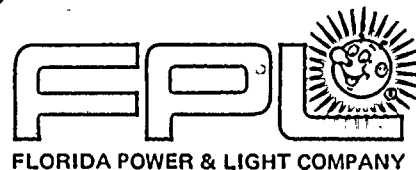

In accordance with the telephone conference of May 23, 1978 with members of your staff, we are making the following commitments regarding start-up physics testing for core Cycle 2 at St. Lucie Unit 1:

- 1) A CEA symmetry check will be performed using Shutdown Group A at zero power with an acceptance criteria of 2 1/2¢.
- 2) We will furnish the NRC with a draft Start-up Physics Test Report within 45 days after completing the Cycle 2 test program. The final report will be submitted within 60 days after completing the test program.
