Dear Mr. Carlson:

Enclosed is Amendment No. 22 to your Nuclear Regulatory Commission (NRC) Materials License No. 21-32035-01 in accordance with your request.

In correspondence dated January 28, 2018, you indicated that you wish to remove and release the facility at 28711 W. Eight Mile Rd., Ste. A, Livonia, MI 48152 for unrestricted use.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this area of use and it is suitable for unrestricted use.

Please note that the request to add authorized users and add 10 CFR 35.300 uses, items 3 and 4 of the submittal, were unable to be completed at this time. A request was made on March 26, 2018 to provide additional information on the requested authorized users in order to approve their intended uses. We will continue our review of your request to add 10 CFR 35.300 uses and associated authorized users, upon receipt of the requested information.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


