The Nuclear Regulatory Commission recently published a Federal Register Notice announcing our intent to submit information collection requests to the Office of Management and Budget (OMB) for 10 CFR Part 54, Requirements for Renewal of Operating Licenses for Nuclear Power Plants. 4. How can the burden of the information collection be minimized, including the use of automated collection techniques or other forms of information technology?
