Dear Administrative Judges:

On January 12, 2016, the Atomic Safety and Licensing Board (“Board”) directed the NRC staff (“Staff”) to provide, within 10 days of the issuance of the last Staff licensing review document in the Crow Butte Marsland Expansion Area (MEA) proceeding, “an estimate of when the staff believes it will be able to give the Board a new estimate for the completion dates for the staff’s draft and final environmental review documents in [the North Trend] proceeding.”¹ On April 30, 2018, the Staff notified the MEA licensing board of the availability of the Staff’s final Environmental Assessment for the MEA.²

With this letter, the Staff is notifying the Board that the North Trend environmental review remains suspended at the request of the applicant.³ Accordingly, the Staff is unable to provide estimated completion dates for the draft or final environmental review documents at this time.
