Enclosed is Amendment No. 15 to your NRC Materials License No. 13-32049-01 in accordance with your request dated January 4, 2018.

Please note that your license is now in landscape format in accordance with NRC policy. Also, certain items and conditions of your license have been changed or removed per current NRC policy. Specifically, former Condition 19 regarding transportation was removed since this is now referenced in the preamble of the license. Also, Item 9 and Conditions 10 and 11 were significantly updated.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
