Please note:

Your request seeks access to all radiation measurements taken in Japan or within 300 nautical miles of the Fukushima Daiichi Nuclear Power Plant, during time frame March 11, 2010 to March 11, 2012

NRC staff has confirmed that the subject request , as written, is overly broad.

Since you stated that you do not agree to pay any fees, and you were denied a fee waiver, you are entitled to 2 hours search time free of charge as well as 100 pages free of charge as a non-excepted requester without incurring any fees. Please note that the scope of your request as written exceeds the 2 hours search free of charge and the 100 pages free of charge.

It is incumbent upon you, as the requester, to fashion a request that asks for records within the 2 -hour search time and 100 pages free of charge threshold for which no fee would be owed if you are unwilling to pay fees.
