SUBJECT: PERIODIC REVIEW OF REGULATORY GUIDES

This is in response to your memorandum dated April 30, 2018, in which you requested the U.S Nuclear Regulatory Commission, Office of Nuclear Material Safety and Safeguards (NMSS) staff to perform a periodic review of selected Regulatory Guides (RGs) that are assigned to our respective Divisions. In your memorandum you also requested us to provide a timeframe for updating the office instructions to incorporate the periodic reviews of RGs.

Enclosure 1 provides the summary results of the NMSS staff review of the specified RGs. The periodic review of these RGs was completed in May 2018 and was conducted by the NMSS staff from the Division of Fuel Cycle Safety, Safeguards, and Environmental Review, Division of Spent Fuel Management, and Division of Decommissioning, Uranium Recovery and Waste Programs.
