The U.S. Nuclear Regulatory Commission (NRC) has completed the “Final Environmental Assessment for the Renewal of SUA-1350, Sweetwater Uranium Project in Sweetwater County, Wyoming.” The final Environmental Assessment (EA) includes an analysis of relevant environmental issues and documents the NRC staff’s determinations regarding the environmental impacts from continued operations at the Sweetwater Uranium Mill. The NRC also conducted a technical evaluation of the license amendment request submitted by the Kennecott Uranium Company (KUC) pursuant to the regulatory requirements in Title 10 of the Code of Federal Regulations (CFR) Part 40, “Domestic Licensing of Source Material,” and 10 CFR Part 20, “Standards for Protection Against Radiation.” The results of the technical evaluation and environmental review inform the NRC’s decision on the requested license renewal request.
