I work for the Nuclear Regulatory Commission (NRC). My office at NRC received copies (3) of an amendment to a standby trust agreement that was established by NRC licensee Homestake Mining Company of California (Homestake). The copies have been signed by both the licensee Homestake and Citibank as the Trustee. Your name appears attesting to Citibank's signing. The NRC normally signs all three copies, keeping one, and returning the other two for the licensee and Trustee. It appears that NRC received three color copies as opposed to three duplicate original signatures. Is Citibank, as the trustee, okay with receiving one of these copies back with only NRC's signature block being an original signature? Please advise.
