Hello Ms. Green,

On April 12, 2018, the NRC invited several Tribes to participate in the U.S. Nuclear Regulatory Commission's (NRC's) selected approach to identify historic, cultural, and religious sites of significance to the Lakota Sioux Tribes at the Dewey-Burdock in situ uranium recovery project in Fall River and Custer Counties, South Dakota. Based on input from the Oglala Sioux Tribe, a party to the adjudicatory proceeding concerning the Dewey-Burdock site, the NRC's April 12 invitation was extended to Oglala Sioux Tribe, Cheyenne River Sioux Tribe, Rosebud Sioux Tribe, Standing Rock Sioux Tribe, Yankton Sioux Tribe, Crow Creek Sioux, and Flandreau-Santee Sioux Tribe. Based on the input of the NRC staff's recently onboarded contractor, the NRC staff is hereby extending the same invitation to the Lower Brule Sioux Tribe.
