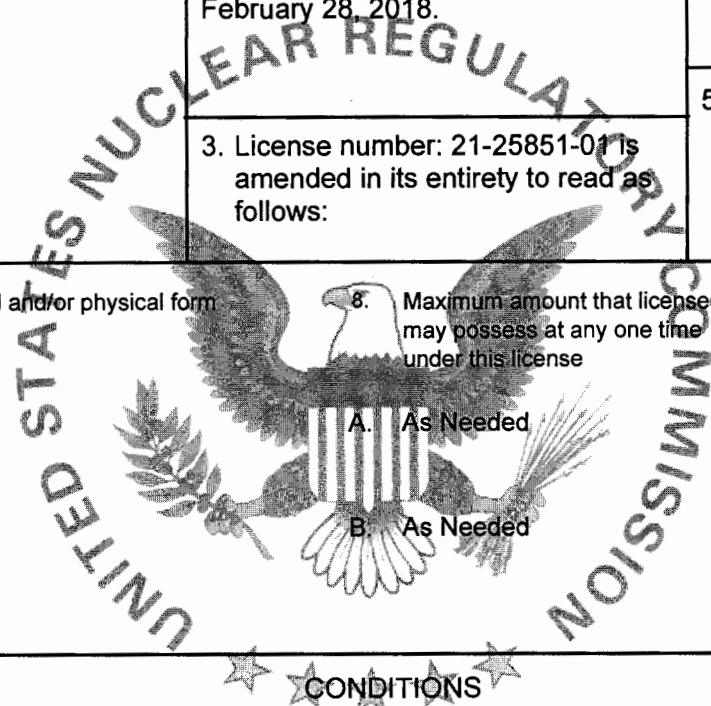


MATERIALS LICENSE

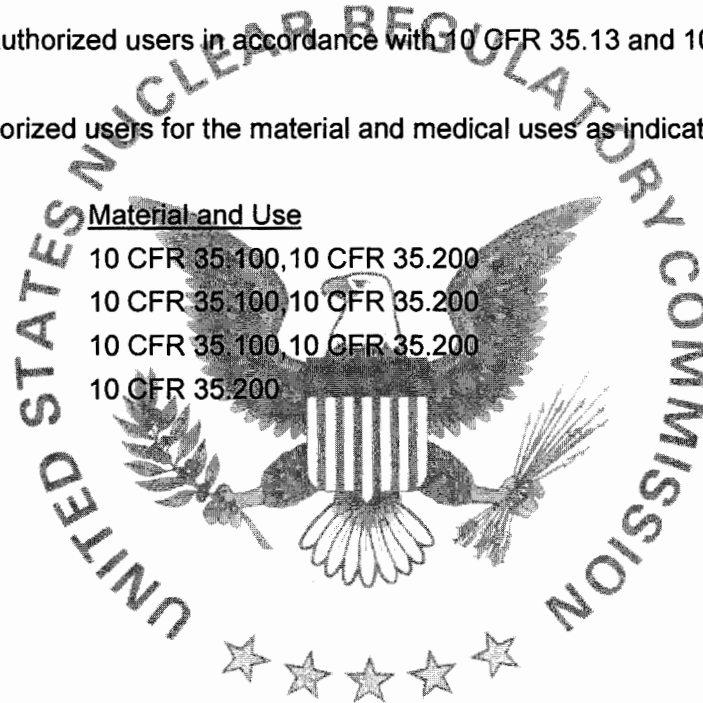

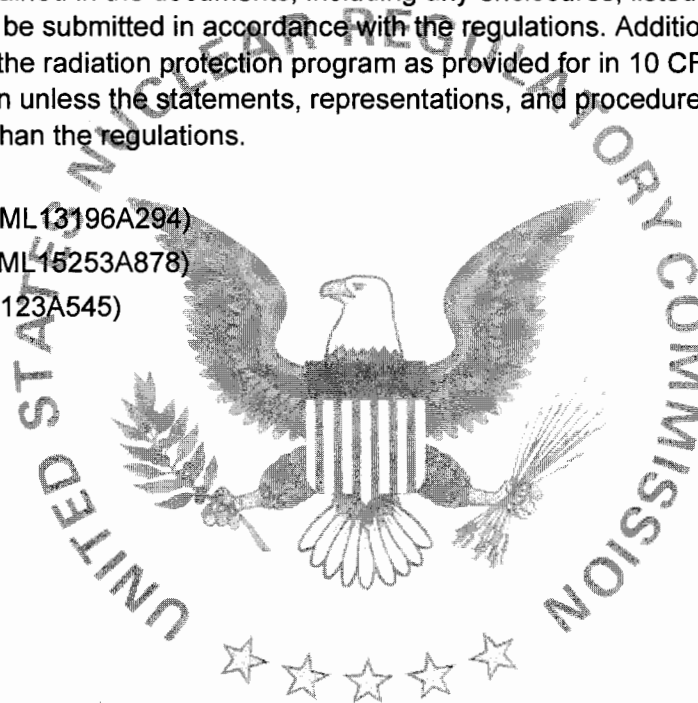
