This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if a former Information Technology infrastructure project manager from HCL America in New Orleans, Louisiana, was subjected to discrimination for raising what he/she believed were nuclear safety concerns. Based on the evidence developed during the OI investigation, the NRC could not substantiate that discrimination occurred.
