Enclosed is Amendment No. 70 to your Nuclear Regulatory Commission (NRC) Materials License No. 21-03210-01 in accordance with your request.

In correspondence dated March 20, 2017 you indicated that you wish to remove and release the facility at 46591 Romeo Plank, Ste. 135, Macomb, MI 48044 for unrestricted use.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this area of use and it is suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


