SUBJECT: NORTH ANNA POWER STATION, UNITS NOS. 1 AND 2, AND SURRY POWER STATION, UNITS 1 AND 2/NUREG-0737, ACTION PLAN ITEM II.K.3.5, RCP TRIP ISSUE (TAC NOS. 49665, 49666, 49681 AND 49682)

The NRC staff has generically approved the Westinghouse Owners Group (WOG) methodology specified in Generic Letter 85-12. In addition, the staff's review of plant-specific information for NA-1&2 and Surry-1&2 allows the staff to conclude that the WOG methodology has significantly improved reactor safety and there are no remaining safety-significant concerns for NA-1&2 and Surry-1&2 plantspecific information. Based on the above, the staff concludes that the issue of NUREG-0737 Action Plan Item II.K.3.5 has been satisfactorily resolved for NA-1&2 and Surry-1&2. Therefore, the NA-1&2 and Surry-1&2 Tac Nos. specified in the subject above are closed.


