Dear Mr. Hollenbeck:

This letter is to inform you of activities that may occur as a result of a potential violation of your U. S. Nuclear Regulatory Commission license issued under Title 10, Code of Federal Regulations, Part 55 (10 CFR 55).

On October 2, 1992, the NRC received a report from the Virginia Electric and Power Company regarding your reported use of marijuana. A subsequent positive test for marijuana was indicated from a sample provided by you on September 24, 1992. The NRC intends to gather more information regarding this occurrence for possible enforcement action as provided by 10 CFR, Part 2, Appendix C, Section VIII, Enforcement Actions Involving Individuals. The enclosed letter to Virginia Electric and Power Company requests this information.

Compliance with the Fitness-For-Duty guidelines of 10 CFR Part 26, Appendix A, is a condition of your individual operator's license. You were provided, via Generic Letter 91-16, dated October 3, 1991, a copy of the applicable amendments to 10 CFR Parts 2 and 55 that were in effect on the date the positive test results were reported. The descriptions therein will provide you with information regarding potential NRC actions in this matter. You will be advised by separate correspondence of any additional action the NRC deems necessary.
